INFORMATION CLAUSE - VISUAL MONITORING



IN ACCORDANCE WITH THE ART. 13 SEC. 1 AND SET. 2 OF THE GENERAL REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL (EU) 2016/679 OF 27 APRIL 2016 ON THE PROTECTION OF INDIVIDUALS WITH REGARD TO THE PROCESSING OF PERSONAL DATA AND ON THE FREE MOVEMENT OF SUCH DATA AND THE REPEAL OF DIRECTIVE 95/46/EC (GDPR), WE INFORM AS FOLLOWS:

3. Purposes of personal data processing and legal basis for processing

Your personal data processed in order to ensure the safety of employees or protect property or control production or keep confidential information, the disclosure of which could expose the Administrator to damage, i.e. pursuant to art. 6 sec. 1 point c GDPR to the extent covered by the generally applicable law and pursuant to Art. 6 sec. 1 point f of the GDPR in connection with significant legitimate needs of the Administrator in the field of collecting data of persons who are not employees of the Administrator.

4. Categories of personal data

The administrator processes the following categories of your personal data: image.

5. Personal data retention period

Your personal data will be stored until the expiry of their archiving period, i.e. for the period of 30 days.

6. Recipients of personal data

Personal data may be made available to the entities providing or maintaining the Administrator's IT infrastructure, entities and persons providing services to the Administrator and other entities to whom the Administrator entrusted personal data (processors) in order to exercise the rights and obligations arising from the concluded civil law contracts, as well as the bodies authorized to receive personal data on the basis of legal provisions.

7. Data transfer outside the European Economic Area:

Currently, we do not transfer your data outside the European Economic Area. If it is necessary in connection with the services provided to the Administrator by third parties referred to in the paragraph above, we reserve the right to transfer your personal data to the recipients located outside the European Economic Area and the European Union. We guarantee that the transfer will always be

carried out in accordance with the applicable provisions on the protection of personal data and an appropriate level of protection of your data will be ensured.

8. Rights related to the processing of personal data

You have the following rights related to the processing of personal data:

- 1) the right to withdraw your consent to the processing of your personal data,
- 2) the right to access your personal data,
- 3) the right to request rectification of your personal data,
- 4) the right to request the deletion of your personal data,
- 5) the right to request limitation of the processing of your personal data,
- 6) the right to object to the processing of your data due to your specific situation in cases where we process your data on the basis of our legitimate interest,

To exercise the above presented rights, please contact us (contact details are included in point 2 above).

In addition, you have the right to lodge a complaint with the President of the Office for Personal Data Protection (in accordance with point 9 below).

9. The right to submit a complaint with the authority

In addition, you also have the right to submit a complaint with the supervisory body dealing with the protection of personal data, i.e. the President of the Office for Personal Data Protection with its registered office at ul. Stawki 2 in Warsaw (postal code: 00-193).

10. The requirement to provide data

Allowing us to register your image within the framework of monitoring is voluntary, however, it is necessary for you to be able to remain at our premises or in other of our facilities.
